## **List of hazardous pesticides in world production of fresh fruit & vegetables**

The Swedish Food Retailers' Federation (Svensk Dagligvaruhandel) has developed a list to support the member companies in their purchasing of fresh fruit & vegetables, to avoid highly hazardous pesticides. The aim is to protect workers, ecosystems and local inhabitants in countries outside of EU where highly hazardous pesticides still are being used.

The list will be updated annually.

The substances in the list are unacceptable for moving towards a sustainable development, they are either highly hazardous to human health or to the environment. All substances are prohibited within the EU and most of them are listed on Pesticide Action Network (PAN) list over highly hazardous substances. Pesticide Action Network (PAN) list of highly hazardous pesticides shows a more complete list of pesticides that need to be phased out in the long run to reach a toxic free and sustainable development.
